The National Police Chiefs' Council (NPCC) Police Operational Advice and Security Industry Requirements for Response to Security Systems has been adopted by Police Service of Northern Ireland (PSNI) and can be found at www.policesecuritysystems.com and www.psni.police.uk. The following variations permitted under the terms of this document apply to this police area.

The PSNI Service Standard aim is to attend emergency calls within 15 minutes and priority calls within 60 minutes.

2.3. List of Compliant Companies Installing Type A Security Systems

(b) Addition - PSNI will carry out criminal record checks every five years, this will be implemented on a staggered basis.

Appendix C (viii) – A police check will include local police records and will not be restricted to PNC only. The police reserve the right to find an applicant unsuitable for reasons other than unspent convictions should police information demonstrate that the applicant is otherwise unsuitable to have access to premises and information relating to the security of premises. Should the police hold information other than criminal convictions that renders the applicant unsuitable, the police will reply stating the individual “has not met the criteria”.

(f) Logistics dictate that Compliant Companies operating in Northern Ireland must have a minimum of two engineers with a 4 hour maximum response time. These engineers will be subject to criminal record checks by the PSNI.

The processing time for Appendix C check is approximately 2 – 6 weeks, provided paperwork has been completed correctly and all the necessary additional paperwork is supplied.

2.6. Notice to Install – Type A Security Systems

2.6.2

The PSNI require that a Certificate of Compliance (NSI)/Conformity (SSAIB) be supplied when submitting URN application.

The processing time for URN applications is approximately 2 – 3 weeks, provided paperwork has been completed correct and all the necessary additional paperwork is supplied.
