- <sup>1</sup> This figure covers emergency response times where the time of arrival is available, duplicate incidents and false alarms are excluded. During the previous financial year to date there were a total of 12,166 such emergency response incidents. An arrival time was available for 65.2% (7,928) of these incidents while there was no arrival time available for 4,238 incidents. During the current financial year to date there were a total of 7,968 such emergency response incidents. An arrival time was available for 74.8% (5,959) of these incidents while there was no arrival time available for 2,009 incidents.
- <sup>2</sup> The crime figures for target 3.1.1 presented in this report for the current financial year to date include both crimes already validated by Central Statistics Branch and incidents known to be crimes but which are currently under process. Using this more inclusive figure gives a more accurate indication of the change in crime between the current and previous financial years to date. This undercount is only available for overall crime levels. It is not possible to provide an undercount in relation to the targets for violent crime, criminal damage and domestic burglary.
- <sup>3</sup> The rural and urban figures for 2007/08 may not add to the overall total as some crimes have yet to be allocated to a District Command Unit.
- <sup>4</sup> The sickness figures are measured against what would be expected for each month on a cumulative basis. The target for police officers and civilian staff is 10 days which equates to 0.83 days for each month. On a cumulative basis this becomes 0.83 for April, 1.67 for April-May, 2.5 for April to June etc. The total average working days lost for the current financial year to date are presented against these targets.
