

FEB advice re banded transactions – version 20th May 2016

From	To	Fee and who deals with it
1. Rifle - no sound moderator	Rifle – no sound moderator – same band	£15 fee - dealer makes exchange and advises FEB within 72 hrs. of the transaction & application ID's and the details of the rifles on Form 30/50
Moderators	To	Fee and who deals with it
2. Moderator	Moderator – within band	£15 fee - dealer makes exchange and advises FEB within 72 hrs. of the transaction & application ID's and the details of the moderators (serial numbers MUST be included if known)
3. Rifle - separate sound moderator	Rifle - no separate sound moderator	2 transactions, 1 off (no fee – no transaction ID required) and 1 on £15 fee – dealer makes exchange and advises FEB within 72 hrs. of transaction & application ID's and details of rifles/moderator on Form 30/50
4. Rifle - separate sound moderator	Rifle - separate sound moderator within band	2 on - 2 off, so 2 x £15 fee - dealer advises FEB within 72 hrs. of transaction and application ID's and details of the rifles/moderators on Form 30/50. Total £30
5. Rifle - no separate sound moderator	Rifle - separate sound moderator	FEB to process - £30 (2 on - 1 off) or, banded with dealer £15 fee for the rifle on Form 30/50 but apply separately to FEB re moderator £30 fee. Total £45
6. Rifle - no separate sound moderator	Rifle - integral moderator	A rifle with an integral moderator is classified as 1 firearm. 1 on - 1 off £15 fee - dealer advises FEB within 72 hrs. of transaction & application ID's and details of the rifle/rifle with integral sound moderator on Form 30/50. Rifles with integral sound moderators MUST be notified to FEB.
Barrels	To	Fee and who deals with it
7. Barrel	Barrel - within band	£15 fee - dealer makes exchange and advises FEB within 72 hrs. of the transaction & application ID's and the details of the barrels on Form 30/50
8. Rifle with extra barrel(s)	Rifle with no extra barrels	Free off for barrel/s (no fee – no transaction ID required) and £15 - dealer makes exchange and advises FEB within 72 hrs. of transaction & application ID's and details of the rifle & barrel(s) on Form 30/50
9. Rifle	Rifle with extra barrel(s)	FEB to process - £30 (?’s on - 1 off) or, banded with dealer £15 fee for the rifle but apply separately to FEB re extra barrels £30 fee. Total £45

10. Damaged barrel	Repaired/or beyond repair and replaced with new barrel of same calibre	No fee (no fee – no transaction ID required) but notify re change of serial number if applicable
Quads		
11. Quad (rifle with 4 barrels)	Quad (rifle with 4 barrels)	This is 4 transactions. So if with a dealer 4 x £15 fee, or if with FEB £30
12. Quad barrel	Quad barrel within band	£15 - dealer makes exchange and advises FEB within 72 hrs. of the transaction & application ID's and details of the barrel on Form 30/50
13. Rifle	Quad (rifle with 4 barrels)	FEB £30, or, banded with dealer £15 fee for 1 rifle ONLY, apply to FEB re extra barrels £30 fee
14. Quad (rifle with 4 barrels)	Rifle	Each spare barrel free off (no fee – no transaction ID required) - then £15 - dealer makes exchange and advises FEB within 72 hrs. of the transaction & application ID's and details of the rifle/barrels

NB. Please be aware that the above advice may change later in the year depending on the transposition of the current proposed EU Directive into our legislation.

NOTES:

- The original FAC is required for the Firearms Dealer to annotate the changes. The dealer must add or change the ammunition allocation as appropriate; the FAC holder must at the time of the transaction dispose of any unused ammunition unless he continues to hold a firearm of that calibre.
- The Form 30/50 **REPLACES** the previous dealer transaction Form 30/35. Each separate transaction requires a £15 fee. 1 off does **NOT** require a fee.
- Moderators may be suitable for rifles in more than one band, please specify if one moderator is to be conditioned for use with more than one rifle. E.g. Moderators could be .22 to .223 inclusive or .243 to .308 inclusive. Also, if the moderator has a make/serial number they **MUST** be provided to FEB.
- A rifle may be exchanged for a rifle, a barrel for a barrel, a moderator for a moderator. Moderators, barrels and rifles **CANNOT** be exchanged for each other.
- No rifle, barrel or moderator that needs FEB approval can be released until the FAC holder produces their updated FAC containing said item.
- A separate Form 30/50 and fee is required for **EACH** FAC holder involved in a change where there is a 'borrowed' firearm.
