APPLICATION FOR FIREARMS CLUB AUTHORISATION

You must complete every section of this form. If a question does not apply to you, please say so. A copy of the current Constitution and/or Rules of your club should be sent with this application. If this is your first application, you must provide the following:

For an outdoor firing range

Two 6-inch ordnance maps showing the range's firing points, stop butt and danger area, if any. All ground within 1,000 yards in rear of butts and 100 yards outside the flank lines of fire must be included.

A plan and section, to a scale of not less than 1/8th of an inch to one foot, of the range firing point, to the stop butt rise.
A copy of the relevant planning permission.

For an indoor firing range

A plan and section, in duplicate, of the range. This must show all doors, windows and skylights; the heights of walls; the section of the roof and the materials (given thickness) of which the building is composed.
Full details of screens and stop butt, must be given.

A site plan of 1/25,000 scale showing all ground within 100 yards of the range.
A copy of the relevant planning permission.
