Request and Answer:

Question 1

Please state how many samples of DNA taken from persons aged under 18 in the Dungannon/South Tyrone area is currently held on the PSNI database. Please break down the figures by age (for example how many aged 16, 15 etc), stating how many of these were suspected of committing a crime, and the range of crimes involved (if applicable).

Question 2

Please state how many samples of DNA taken from persons aged under 18 in the Cookstown area is currently held on the PSNI database. Please break down the figures by age (for example how many aged 16, 15 etc), stating how many of these were suspected of committing a crime, and the range of crimes involved (if applicable).

Question 3

Please state how many samples of DNA taken from persons aged under 18 in the Omagh area is currently held on the PSNI database. Please break down the figures by age (for example how many aged 16, 15 etc), stating how many of these were suspected of committing a crime, and the range of crimes involved (if applicable).

Question 4

Please state how many samples of DNA taken from persons aged under 18 in the Strabane area is currently held on the PSNI database. Please break down the figures by age (for example how many aged 16, 15 etc), stating how many of these were suspected of committing a crime, and the range of crimes involved (if applicable).

Answer

The PSNI does not retain the requested information in an easily retrievable format, therefore the cost of complying with your request for information would exceed the "appropriate limit" as stated in the Freedom of Information Regulations 2004, which is currently set by the Secretary of State at £450.

The requested information would require an extraction from several information systems, staff would have to redirect from current work to complete this enormous task. To do this would impact on the PSNI's ability to deliver front line policing, which would also impact on the wider community.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

You may wish to submit a refined request in order that the cost of complying with your request may be facilitated within the 'appropriate limit'. Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

The PSNI have also considered whether we can be of any assistance in terms of helping you refine your request to bring it under the cost limit however the nature and structure of the information unfortunately makes this extremely difficult.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
