## FREEDOM OF INFORMATION REQUEST

**Subject:** Arrests of Individuals Over 65 Years Old

### Request and Answer:

I am writing to confirm that the Police Service of Northern Ireland has now completed its search for the information.

I have today decided to:

- disclose information in response to question 1 in full;
- disclose information in response to questions 2 and 3 subject to the deletion of information pursuant to the provisions of Section 40(2)(a) of the Freedom of Information 2000 (the Act)

### Question 1

I would like to request the following under Freedom of Information.

How many people over the age of 65 were arrested by the PSNI over the last three years?

### Answer

In 2007 there were 238 arrests  
In 2008 there were 256 arrests  
In 2009 there were 259 arrests

### Question 2

Could this information be broken down into gender, location and the age of each person arrested?

### Question 3

What were these people arrested for?

### Answer

Section 17 of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the information is exempt) to provide you the applicant with a notice which:

- (a) states that fact,
- (b) specifies the exemption in question and

(c) states (if not otherwise apparent) why the exemption applies.

The exemption, as well as the factors the Department considered is listed below:

#### Section 40(2)(a) – Personal Information

The exemption at Section 40 applies to data contained within the attached tables that relates to the location of the arrests. Section 40 is a Class-based exemption, therefore it is not necessary to evidence the harm caused by disclosure. The data protection rights of a third party would be breached by disclosure. Section 40(2) is an Absolute exemption and therefore a Public Interest Test is not necessary. This is so because personal data is governed by other law (The Data Protection Act 1998).

Some of the requested information has resulted in the retrieval of information where only one arrest has occurred for an offence. The location of the arrest is not deemed personal data however it is linked to an individual, so that it provides particular information in relation to his/her arrest. This means that to release the location along with the gender, age and reason for the arrest, could lead to the identity of the individual concerned.

Additionally, there is the potential to identify someone from the data either through a comparison of what is already in the public domain or as an incidental consequence. There is a risk that releasing the information as part of this request could be used in conjunction with what is already known and assist the identification of those arrested.

All requests made under FOIA are applicant blind. A release under the FOI Act is a release into the public domain via the PSNI website, not just to the individual applicant.

To release this information would be a breach of the Data Protection Act and is catered for within Freedom of Information by the exemption under Section 40(2)(a) of the FOIA.

However, I have provided the gender, age and reason for the arrest, for 2007, 2008 and 2009, in the tables at the end of this correspondence, to facilitate your request and promote transparency.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter. In the event that you require a review to be undertaken, you can do so by writing to the Head of Freedom of Information, PSNI Headquarters, 65 Knock Road, Belfast, BT5 6LE or by emailing [foi@psni.pnn.police.uk](mailto:foi@psni.pnn.police.uk).

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
