### Request and Answer:

This is to inform you that the Police Service of Northern Ireland has now completed its search for the information you requested. The decision has been taken to disclose the located information to you in full.

### Question

Please can you provide a breakdown of crimes committed by people either on court bail or police bail in Northern Ireland during the year 2009-2010.

I would ask that this includes a breakdown by crime category (for example murder, criminal damage, robbery) and the total offences for each year.

I am making this request under the Freedom of Information Act.

The information is to supplement an earlier request: F-2010-00002.

### Answer

Please see the tables at the end of this correspondence, detailing a breakdown of the crimes committed whilst on bail and the total number of offences for 2009 and 2010.

Please note the earlier results in FOI 2010-00002 for the year 2009 are slightly lower. The probable reason for the figures being slightly higher now, as opposed to when the results were obtained in January, is persons on continuing bail have subsequently committed offences after the script was previously run in January.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
