Answer

Please find attached Prompt Payment Reports for December 2009, March 2010 and September 2010, at the end of this correspondence. The performance reports and percentages contained in the reports for the 3 periods have been rounded to 1 decimal place, whereas the figures supplied in the previous request FOI-2010- 02617 were rounded to 2 decimal places. This is the format of the formal performance reports issued by PSNI, externally.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House,

Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
