- 3. A breakdown of the number of PSNI officers per rank who successfully registered second jobs for each of the last three financial years
- 4. How many PSNI officers unsuccessfully (i.e. were rejected) registered second jobs in each of the last three financial years (2007/08, 2008/09 and 2009/10)
- 5. A breakdown of the type/nature of registered second jobs (if any) referred to in question one for each of the last three financial years
- 6. A breakdown of the number of PSNI officers per rank who unsuccessfully registered second jobs for each of the last three financial years
- 7. How many PSNI officers successfully registered business interests in each of the last three financial years?
- 8. A breakdown of the type/nature of registered business interests (if any) referred to in question four for each of the last three financial years
- 9. A breakdown of the number of PSNI officers per rank who successfully registered business interests for each of the last three financial years
- 10. How many PSNI officers unsuccessfully (i.e. rejected) registered business interests in each of the last three financial years?
- 11. A breakdown of the type/nature of registered business interests (if any) referred to in question four for each of the last three financial years
- 12. A breakdown of the number of PSNI officers per rank who unsuccessfully registered business interests for each of the last three financial years

Answer

Records do not differentiate between Second Jobs and Business Interests, i.e they are both recorded as Business Interests. Please see tables below which refer to questions 1 to 6, but it

should be noted that the figures do include Second Jobs and Business Interests.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
