Request and Answer:

This is to inform you that the Police Service of Northern Ireland has now completed its search for the information you requested and the answer to your questions are as follows:

Question 1

Can you please provide information regarding the recruitment of the Op Exposure PSNI officer currently based at Strand Road PSNI station?

Answer

No-one has been permanently appointed to the Op Exposure role. There is currently one officer on a Temporary Secondment to the Op Exposure role. The purpose of this temporary role is to conduct a pilot of the Op Exposure scheme for potential role out across the Service.

Question 2

Can you please provide the date this post was advertised to Police?

Answer

The role was not advertised to all Constables. The role was trawled amongst Chief Inspectors and Inspectors, requesting them to identify suitable officers for the temporary role.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.

Operation Exposure involves the management of CCTV images, from seizure by Police through various indentification methods including, where appropriate, release to the media and the subsequent collection and dissemination of intelligence back to investigating officers for action. An officer/s is required on a temporary basis, (not anticipated to be longer than 3 months duration), to manage Operation Exposure in G District and extend it from Foyle to the whole of the District. The role will involve establishing systems and procedures to support the Operation. This is a Pilot for the Service and the officer involved may be required to assist in communicating the Operation to other District in the following months.

Essential Criteria

Police Driving Card
Access to private vehicle
Must have good written and verbal communication skills and be able to meet with external individuals and organisations

Desirable Criteria

A thorough knowledge of NICHE Thorough knowledge of Intelligence submission procedures Knowledge of Volume Crime Model
