## FREEDOM OF INFORMATION REQUEST

**Subject:** Policing Parades In Keady Richill and Armagh City

### Request and Answer:

I am writing to confirm that the Police Service of Northern Ireland (PSNI) has now completed its search for the information you requested.

### Question

To provide the total cost of policing parades in Keady, Co Armagh during 2006,2007,2008,2009 and 2010.

### Question

To provide the total cost of policing parades in Richhill, Co Armagh during 2006, 2007, 2008, 2009 and 2010.

### Question

To provide the total cost of policing parades in Armagh City during June, July and August during 2006, 2007, 2008, 2009 and 2010.

**Please note that whilst you have asked 17 questions in separate correspondence, these questions have been aggregated into one request in compliance with section 12(4) of the Act as they all relate to the same subject.**

### Answer

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000, which is currently set by the Secretary of State at £450.

I have been advised by E District that your request covers all the parades in the Armagh area over a 5 year period and that there are over 250 parades in this period. To ascertain the cost of policing these would require research of each one individually and allowing approximately 30 minutes per parade would take approximately 125 hours for one year which in itself is well in excess of the

amount (18hours) permitted by the legislation.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

The Police Service of Northern Ireland have also considered whether we can be of any assistance in terms of helping you refine your request to bring it under the cost limit, however due to the structure and nature of your request makes this impossible.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter. In the event that you require a review to be undertaken, you can do so by writing to the Head of Freedom of Information, PSNI Headquarters, 65 Knock Road, Belfast, BT5 6LE or by emailing [foi@psni.pnn.police.uk](mailto:foi@psni.pnn.police.uk).

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
