**Subject:** Police Raid Requiring Forced Entry to Domestic Dwellings

### Request and Answer:

#### Question 1

Please could you tell me (via email) for the financial years 2009-10, 2008-9, 2007-8 (and, if it will not break the time limit, 2006-7).

How many police raids requiring forced entry to domestic dwellings occurred in your force area for each year?

#### Question 2

How much money your force paid in compensation for damage to property during police raids on domestic dwellings?

#### Question 3

The total number of raids which resulted in compensation for each year?

#### Question 4

And if possible, the single largest payout for each year and what it was for?

#### Question 5

If more detailed information is collected (for example: replacing a front door, plastering a wall, etc) and it will not take longer than the maximum time allowance, could you also break down what the other payouts were for?

#### Question 6

Could you clarify whether your force pay compensation if the raid in question leads to a successful conviction of the dwelling occupant/s.

### Answer

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000, which is currently set by the Secretary of State at £450.

To provide a full response to this request would require retrieving all relevant files and reading and extracting the information required.

The information in relation to question 1 is not held in a central location within the PSNI and would require input from each of the eight District Command Units. The only records held by the Districts which may show whether force was used in searches of domestic dwellings are Search Records and Police and Criminal Evidence Act (PACE) forms. One District alone has advised that they receive over 500 Search Records and 4,800 PACE forms each year and manually searching through them to extract the information requested would take hundreds of hours.

In addition, there are approximately 300 files held which are relevant to question 5 of your request and, allowing 5 minutes to check each file, it has been estimated that it would take 25 hours to retrieve the information requested.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

I have also considered how your request may be refined in order that the cost of complying with it may be facilitated within the 'appropriate limit'. Unfortunately the nature and structure of the requested information makes this impossible.

Although excess cost removes the PSNI's obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information relative to your request which was retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

Please see tables below which provide amounts paid by PSNI in compensation for damage to property during police raids on domestic dwellings for the financial years 2006 to 2010. These tables provide responses for questions 2, 3 and 4 of your request. Information supplied is based on claims lodged by members of the public for alleged damage to their property as a result of a police search.

In relation to question 6, I can advise that members of the public are a liberty to lodge a claim for compensation following a police search if they are of the opinion that police were negligent. Any such claim is considered on its own particular merits.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50

of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
