Request and Answer:

This is to inform you that the Police Service of Northern Ireland has now completed its search for the information you requested. The decision has been taken to disclose the located information to you in full.

Question 1

For the years 2011, and 2012 so far:

How many young people aged between 13 and 19 were:

Charged or reported to be in possession of weapons?

Arrested for being in possession of weapons?

Cautioned for being in possession of weapons?

Answer

368 young people aged between 13 and 19 were charged or reported to be in possession of weapons. Some were charged with more than one offence.

148 young people aged between 13 and 19 were arrested for being in possession of weapons. Some were arrested more than once.

14 young people aged between 13 and 19 were cautioned for being in possession of weapons.

Answer

The youngest person caught in possession of an offensive weapon since 2008 was 11 years old. The weapon was a snooker cue.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
