



## FREEDOM OF INFORMATION REQUEST

**Subject:** Thefts from Police Stations and Vehicles

### Request and Answer:

I am writing to confirm that the Police Service of Northern Ireland has now completed its search for the information.

I have today decided to disclose information in response to question 1, subject to the deletion of information pursuant to the provisions of Section 40 of the Freedom of Information 2000 (the Act).

### Question

Under the Freedom of Information Act 2000, I ask for a disclosure of the following information relating to crime at police stations and from police vehicles:

An inventory of all items reported stolen from PSNI stations/buildings and from PSNI vehicles in the last six years (2007, 2008, 2009, 2010, 2011 and 2012-to-date).

I would ask that this includes a description of each item, the estimated value of each item, the station and DCU area, and/or the location of the vehicle, from which each item was taken and the date it was reported missing.

### Answer

Please find the tables attached at the end of this correspondence providing a list of the burglary, robbery and theft offences from police stations/vehicles from 2007 – to date. Please note this information is based on data taken from a live crime recording system and may be subject to change.

This dataset includes some address information where a police vehicle was located at time of an offence taking place. I have decided not to disclose this specific address information. I have also decided to withhold the dates of the incidents.

Section 17(1) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the information is exempt) to provide you the applicant with a notice which:

- (a) states that fact,
- (b) specifies the exemption in question and

(c) states (if not otherwise apparent) why the exemption applies.

The exemption/s, as well as the factors the Department considered when deciding where the public interest lies, are listed below:

Section 40 (2) (a) and (b) by virtue of Section 40 (3) (a) (i) – Personal Information

**Section 40 Personal Information** is a class-based exemption, therefore it is not necessary to evidence the harm caused by disclosure. The data protection rights of a third party would be breached by disclosure, therefore Section 40(2) is an Absolute exemption and a Public Interest Test is not necessary. This is so because personal data is governed by other law (The Data Protection Act 1998). All requests made under FOIA are applicant blind. A request must be treated as such and a public authority will always view any disclosure as into the public domain and not just to an individual.

Personal Data is regulated under the principles of the Data Protection Act 1998 and when information contains personal data about a third party it can only be released if disclosure would not breach any data protection principles.

Principle (1), that personal data is processed lawfully and fairly. Personal data of this nature is recorded and it must be treated in a highly confidential manner and any public disclosure would be unlawful if there is a breach of that law of confidentiality.

When a PSNI officer reports an address at which a theft from a police vehicle took place, the individuals connected with that address will have no expectation that this personal information will be released into the public domain.

The date that an incident took place, along with further specific details of the incident, could be used to identify any individuals involved.

The Service would be failing in its lawful duty were it to breach the Data Protection Act in order to furnish a disclosure under the Freedom of Information Act 2000. The Service has a duty to protect the personal data of all individuals and any disclosure of this type of data into the public domain will be unfair to any individual concerned. The public must have confidence that any of their information is treated sensitively and appropriately. Therefore, in all circumstances of the case, public interest in maintaining the exemption outweighs the public interest in disclosing the information.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible, or in any case within two months of the date of issue of this letter. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner

will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
