**Subject:** PSNI Officers On Duty Caught Speeding 2010 - 2013

**Request and Answer:**

### Question1

How many PSNI officers (excluding those off-duty) were caught speeding in the last four years (2010, 11, 12 and 2013 to date)?

### Answer

This is to inform you that the Police Service of Northern Ireland has now completed its search for the information you requested. The decision has been taken to disclose the located information to you in full.

Please find below a table showing the number of PSNI officers detected speeding whilst on duty by the Northern Ireland Road Safety Partnership over the past four years.

June – December 2010	2011	2012	January – September 2013

Please note records are only available from June 2010 following the introduction of a new recording system.

### Question 2

Of these, how many had their offences cancelled/ignored (i.e. were let off). Please explain the reason/s in each case?

### Answer

When a Police Officer is detected exceeding the speed limit, the circumstances are individually examined to determine whether the legal exemption for on-duty officers applies as per Article 42 of the Road Traffic Regulation (NI) Order 1997. Where the legal exemption can be justified, e.g. response to crime in progress, an authorised pursuit or other immediate and serious situation, then the notice will be voided. The specifics of each exemption would require a manual trawl through the paperwork for the 312 such cases. It is estimated that this would take 5 minutes per case, equating to 26 hours to extract this information exceeding the total time allowed per request which is 18 hours.

### Question 3

How many off-duty PSNI officers were caught speeding in the last four years (2010, 11, 12 and 2013 to date)?

### Answer

The driver of a vehicle detected speeding is not required to provide details of their occupation, therefore this information is not recorded.

### Question 4

Of these, how many off-duty officers had their offences cancelled/ignored (i.e. were let off). Please explain the reason/s in each case.

### Answer

### Question 5

How many PSNI officers (excluding those off-duty) were disciplined after being caught speeding on speeding cameras in the last two financial years (2006/07 and 2007/08)?

**Clarification received** amending these dates to last four years – 2010/11/12/13 and detected by any means of speeding.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
