Request and Answer:

Question 1

The number of people caught driving without insurance in F District in 2012-13 and 2013-14, and broken down by are i.e. Cookstown, Dungannon etc.

Question 2

The number of people caught driving without insurance in G District in 2012-13 and 2013-14, and broken down by area i.e. Magherafelt etc.

Question 3

The number of people prosecuted for driving without insurance in 2012-13 and 2013-14 in both F and G Districts and again broken down by area.

Clarification received: Yes that would be fine; the 'number of people referred for prosecution' will suffice for Question 3. Could I request the number of people prosecuted for just F District then and broken down by area?

Answer

This is to inform you that the Police Service of Northern Ireland has now completed its search for the information you requested. The decision has been taken to disclose the located information to you in full.

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
