Further to FOI request F-2105-02996, in respect of each case can you provide details of the Article in the PSNI Code of Ethics which was breached?

Answer

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland (PSNI) does hold information to which your request relates. The decision has been taken to disclose the following.

The table below outlines the officers who were disciplined at a Formal Misconduct Hearing, broken down by 'Code of Ethics Article' charges and sanctions.

It should be noted that every Disciplinary Hearing is examined on a case by case basis to determine the level of misconduct and the extent to which the PSNI Code of Ethics has been breached. The seriousness of the offence and the circumstances surrounding its commission would have dictated the sanction(s) ultimately imposed.

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
