#### **Question 1**

Could you please supply number of current Firearm Certificates within each of the 29 DCU areas?

#### **Answer**

This is to inform you that the Police Service of Northern Ireland has now completed its search for the information you requested and the response is as follows.

#### Clarification sought

These records are recorded against station areas and to collate into DCUs would involve manual research of every record. There have been 569 revocations during the requested period and 36,363 variation transactions so to individually search each one and collate into DCUs would well exceed the 18 hour limit. The information is recorded in Station Areas and not DCUs as requested.

#### Clarification received

Yes, please supply in station areas.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
