Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Included below is a table which shows the number of crimes recorded for the calendar years 2014, 2015 and 2016 to 30<sup>th</sup> November 2016 where crimes of a sexual offences had an address identifier of 'Leisure/Swimming Centre', 'Sports Club/Pavilion' or 'Sports Stadium' recorded against the linked incident.

**Please Note:** Data from 1<sup>st</sup> April 2016 onwards is provisional and subject to change. This information is based on data extracted from a live system and is dependent on the information having been input into the system in such a way as to identify those records that are relevant.

The data was extracted from the recorded crime statistics for sexual offences and records were selected where the MO of the incident against which each crime was recorded was set to 'Leisure/swimming centre', 'Sports club/pavilion' or 'Sports stadium. Note that the setting of MO to 'Leisure/swimming centre', 'Sports club/pavilion' or 'Sports stadium' may mean that the crime occurred in or within the vicinity of the described location rather than within its premises.

In addition, a number of recorded incidents will have no location subtype assigned to them and therefore it is possible that some of these records may relate to a relevant location but will not have been picked up by the query run by the PSNI Statistics Branch.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
