Subject: Crimes on Taxi Drivers

Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) I can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000.

Request 1

For each of the calendar years, 2013, 2014, 2015, 2016, 2017 how many crimes have been recorded in which the victim is a taxi driver?

For clarity, I am looking for crimes against taxi drivers which happened while they were working – ie their job was relevant to the crime.

Request 2

For each return please state the nature of the crime for example GBH and if possible a brief narrative summary of the incident.

Request 3

I would be grateful if you could also state the outcome. For example charged, caution ongoing, no suspect identified.

Answer

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The ‘appropriate limit’ is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees)

Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

I have contacted PSNI Central Statistics Branch and they have advised that although the information is held on the NICHE computer it would also require manual intervention to extract the requested information. Information on the occupation of the victim of crime may be recorded on the PSNI system, however this may not relate to an individual's occupation at the time of the recorded offence. This information would also not indicate whether the victim's occupation of 'taxi driver' or 'mini cab driver' was in any way linked or relevant to the actual offence recorded.

To retrieve the information requested would involve reading through all the relevant incidents in order to identify the circumstances of each incident and whether or not each recorded crime was against a taxi driver whilst working. In a previous search completed for a similar FOI request, Statistics Branch identified a total of 302 relevant assault incidents over a two year period, however this information did not indicate whether the occupation data was linked to or relevant to the offence recorded. It was also confirmed that it would take in excess of 50 hours to examine a two period of assault related offences. As this request asks for a longer period of time, as well as all offences, it has therefore been determined that to respond to your request would be greatly in excess of the FOI legislative cost of 18 hours.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

You may wish to submit a refined request in order that the cost of complying with your request may be facilitated within the 'appropriate limit'. In compliance with Section 16 of the Act, I have considered how your request may be refined to bring it under the appropriate limit; unfortunately on this occasion due to the PSNI recording system refinement is not possible. Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. In the event that you require a review to be undertaken, you can do so by writing to the Head of Freedom of Information, PSNI Headquarters, 65 Knock Road, Belfast, BT5 6LE or by emailing foi@psni.pnn.police.uk.

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50

of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
