



## FREEDOM OF INFORMATION REQUEST

**Subject:** Stop and Search

### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

### Request

Since the enactment of both The Terrorism Act 2000 and Justice & Security (NI) Act 2007 the police in the North of Ireland have been afforded the right to stop, detain, search and question individuals which has been deemed compatible with ECHR law. How many Stop and Searches have been carried out by the Police re aforementioned Acts quoted above in the Police district of Derry and Strabane from the following dates 1st October 2017 through 1st June 2018.

### Answer

Between 1 October 2017 and 1 June 2018 the PSNI stopped and searched, or stopped and questioned, 1,173 people in Derry City and Strabane policing district under the Terrorism Act 2000 and/or the Justice and Security Act 2007.

The above statistics relate to persons stopped and searched under the Terrorism Act 2000 sections 43 and 43A and the Justice and Security Act section 24, as well as persons stopped and questioned under the Justice and Security Act section 21. Persons may have been stopped under one legislation or multiple legislations.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
