Subject: Grade1 Response Times

Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) I can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000.

Request 1

What is the mean response time broken down by postcode district for Grade I calls (the most severe), for the year 2018 to the latest possible date? Please display in minutes and seconds

Request 2

What percentage of Grade I calls were responded to within 15 minutes, broken down by postcode district, for the year 2018 to the latest possible date?

Answer

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The ‘appropriate limit’ is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the ‘Fees Regulations’ for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

(i) determining whether the information is held;

- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

Enquiries made in relation to your request has identified that retrieval of information would exceed the 18 hour cost limit set by the Secretary Of State under the FOI Act. The PSNI's Urban Contact Management Centre has stated there are no statistics routinely held to answer this request. A search of PSNI Command and Control system would not provide reliable results either as PSNI would rely heavily on arrival times. PSNI already know that these are extremely unreliable due to call signs not giving arrival times at all or giving late arrival times or the incident being scheduled to a later time or date to be attended either due to call volume or by agreement with the caller. To provide an accurate answer to the question, each and every call would have to be examined and assessment carried out as to the accuracy of the information contained therein. The time taken to assess every call over the time period specified would be far in excess of time limits due to the number of 999 calls. PSNI Central Statistics Branch have advised that the number of Emergency response calls for 2018 totalled 23,952. Allowing approx. 3 minutes each to assess each of these incidents would take well in excess of 1000 hours that is even before trying to separate data by postcode and averaging it.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

You may wish to submit a refined request in order that the cost of complying with your request may be facilitated within the 'appropriate limit'. In compliance with Section 16 of the Act, I have considered how your request may be refined to bring it under the appropriate limit. I am unable to offer you refinement for this request.

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
