It was agreed that the balance of resource should be carefully managed.</p>	
<p><b>4.0</b></p>	<p><b>Corporate Expenditure</b></p> <p>The Head of Strategic Financial Management Services presented the reports, highlighting the key figures.</p> <p>The projected pressure due to hearing loss is £52.8m. The funding arrangements for Hearing Loss and Equal Pay are still to be agreed.</p> <p>The COINS report was also presented for information.</p>	
<p><b>5.0</b></p>	<p><b>Corporate Risk Register</b></p> <p>The total number of risks stand at 7.</p> <p><b><u>CCF01 Hate Crime</u></b> – This risk remains at 3, 3 (Serious, Very Likely). All actions are within time limits.</p> <p><b><u>CCF02 Crime Investigations</u></b> – This risk now has the revised rating of 3, 3 (Serious, Very Likely), as agreed at October CCF. All actions are within time limits.</p> <p><b><u>CCF03 Terrorist Attack</u></b> – This risk remains at 4, 4 (Major, Almost certain). All actions are within time limits.</p> <p><b><u>Other Risk considerations</u></b></p> <p>The issue of geographic risk was discussed. The Chief Constable queried if and how we currently measure it. It was agreed that the measuring of risk by geographical areas should be further developed.</p>	<p>The Chief Constable directed that consideration be given to how geographic risk can be captured.</p>
