NI Motoring Offences National Statistics Assessment – Action Plan

The PSNI motoring offences statistics are currently undergoing assessment by the Office for Statistics Regulation (OSR) to determine if they fully comply with the Official Statistics Code of Practice and meet the highest standards of trustworthiness, quality and public value. Following an initial assessment and user consultation, OSR have proposed that if the following requirements are met in full, the statistics will be awarded National Statistics status.  We consider that it would be valuable to a wider user base, as well as being more efficient for the statistics team, for the team to review these additional analysis requests, with a view to developing published statistics to pre-emptively meet these needs. 	 a. By mid-November 2019, review all internal and external motoring offences queries on the Statistics Branch information requests database over the last 12 months, in order to identify trends in areas or topics. These will be reviewed on an annual basis, ensuring any new common themes are identified and published where possible. b. Assess the viability and potential vehicles (e.g. monthly / annual reports, Open Data etc) for publishing
	additional information based on the most requested, to be completed mid-November 2019 to allow for additions to the Nov monthly report initially, if possible.
	c. Ongoing liaision with internal and external users including colleagues in PSNI, DfI, PCSPs and road safety groups, in relation to their primary data requirements and preferred formats. This will include face to face meetings, presentations, surveys, email and telephone contact.
