Please can you provide copies of any current policies and guidance documents held by your Police force/constabulary in relation to dealing with Gypsy, Roma, Traveller (GRT) communities?

In particular any policies/guidance relating to the handling of complaints of anti-GRT discrimination and/or dealing with complaints made about GRT communities?

## Answer

Your request for information has now been considered. In respect of Section 1(1) (a) of the Act we can confirm that the Police Service of Northern Ireland does not hold information in relation to your requests. Enquiries made in relation to your request failed to locate any records or documents relevant to your request based on the information you have provided. PSNI do not have any policies or guidance documents specific to the 'GRT' communities. Accordingly, we have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.
