Subject: Arrests for Violation of Covid 19 Restrictions

Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates and the decision has been taken to disclose the following.

Request 1

My request relates to the number of people arrested by the police force as a result of a violation of restrictions put in place during the COVID-19 pandemic. Specifically, I would like the following information.

How many individuals have been arrested for breaking COVID-19 restrictions since the beginning of the UK's first national lockdown on March 16, 2020. I would like this data broken down by month between March 16, 2020 and today's date. If data has not been included up to and including today's date, please provide me with data starting from March 16, 2020, to the latest date where data is available.

Request 2

In addition to providing the total number of people arrested for breaking COVID-19 restrictions since the beginning of the UK's first national lockdown on March 16, 2020, please clearly highlight per month, what percentage of these arrests were made against individuals that identify as BAME (Black, Asian or minority ethnic).

I would also like to receive the information in an electronic format.

Answer

Please see the table below detailing custody records each month for the period March 2020 to date where a person was processed through custody for at least one arrest under Coronavirus legislation.

Notes applicable to the data provided

During the time period requested there have been 151 custody records where a person has been arrested for at least one offence under Coronavirus legislation. There have been 140 different individuals arrested; some individuals have been arrested on more than one occasion.

The ethnicity information is based on the details held on the person's NICHE nominal record. PSNI

Statistics Branch cannot make any inference as to whether the person identifies as BAME.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
