#### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland (PSNI) does hold information to which your request relates. The decision has been taken to disclose the following:

For each of the individual 33 months from April 2019 to December 2021 inclusive:

## Request 1

The total number of authorised detentions of adult suspects (aged 18 or over).

## Request 2

The total number of authorised detentions of adult suspects (aged 18 or over) in which the need for an appropriate adult (under PACE Code C) was recorded.

It would be very helpful if the data could be provided in a table or Excel format.

#### **Answers**

In response to you Requests, please see the table below.

This table illustrates the total number of adults detained, in addition to those requiring an appropriate adult. The figures have been broken down over the course of the requested 33 month period.
