# FREEDOM OF INFORMATION REQUEST

Subject: Strip Searches 2019 - 2021

#### Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner's Office guidance 'Requests where the cost of compliance exceeds the appropriate limit' in relation to this request, which also provides further detail on the application of Section 12 (1) of the FOIA. You requested the following information from PSNI:

#### Request

I am writing under the Freedom of Information Act to request the below information regarding the use of strip searching by your police force - that is, involving the removal of more than just the suspect's outer clothing. For each of the years 2021, 2020, 2019, please provide the below information:

## Request 1

How many people have been strip searched in your police force area in each of the above years? Please include:

- a. the individual's age (If you are unable to give exact ages, please use the following brackets: 1-10; 11-14; 15-17; 18+);
- b. the sex of each of those searched; and
- c. their ethnicity.

## Request 2

Please indicate the outcome/result of that search (in terms of whether anything was found, whether action was taken, etc)

### Request 3

Please indicate whether an appropriate adult was present during the search, and please indicate cases where an individual declined to have an appropriate adult present

I would welcome any assistance on how to refine this request. Please send any queries or guidance, as well as the final information

#### Answer

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The 'appropriate limit' is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it:
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

PSNI can advise prior to 2020 this information was not stored centrally on our database. Whilst this information is held on the custody record of each person, it is not held in a retrievable format that provides the information without manual intervention and a comprehensive search would need to be conducted to determine if a 'Strip Search' had been conducted. PSNI have identified that each year approximately 25,000 individuals are processed through custody. Allowing one minute reviewing each individual person's record amounts to over 416 hours of work, grossly exceeding the legislative timescale of 18 hours. In addition to this, each record would need examined to determine the answers to parts 2 and 3 of your request further adding to the time provided.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

### **Advice and Assistance**

You may wish to submit a refined request in order that the cost of complying with your request may be facilitated within the 'appropriate limit'. In compliance with Section 16 of the Act, we have

considered how your request may be refined to bring it under the appropriate limit and can advise as follows:

- PSNI can provide the numbers of people subject to strip searches for the years 2020 and 2021 by age group and gender.
- PSNI can provide the numbers of people subject to strip searches for the years 2020 and 2021 by ethnicity.

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
