Request and Answer:

Your request for information has now been considered. In respect of Section 1(1) (a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request

I am respectfully requesting under the Freedom of Information Act, with respect to GDPR, the total number of incidents involving individuals entering the Foyle River and attempting to enter, from March 23rd 2020 up to this day, 28th March 2021.

If you could provide the data by gender, and age groups in a way that won't identify individuals.

Answer

Please see the table below, which details persons entering the River Foyle at the bridges between the 23rd March 2020 and 23rd March 2021.

These figures contain unknown ages in both males and females, and figures where the Policing District does not have any information on the age or sex. These will be persons rescued by either passer-by's, family, the Foyle Prevention Team or Maiden City River Watch.

Please note: There was a total of five deaths on the River Foyle in this time period.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
