Subject: Wildlife Crimes Committed Against Red Kites

Request and Answer:

Request 1

Do the PSNI hold information on wildlife crimes committed, or suspected to have been committed, against Red Kites in Northern Ireland since January 2017?

Request 2

If so, in what areas have these crimes, or suspected crimes, been committed?

Request 3

How many incidents of wildlife crime, or suspected wildlife crime, have been committed against Red Kites in Northern Ireland since 2017?

Answer to Requests 1-3

Section 17(1) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the information is exempt) to provide you the applicant with a notice which:

- (a) states that fact,
- (b) specifies the exemption in question and
- (c) states (if not otherwise apparent) why the exemption applies.

Pursuant to the provisions of Section 22 of the Freedom of Information Act 2000 it has been decided to refuse access to the information you have requested. Under Section 22 (1) of the Act the Police Service of Northern Ireland (PSNI) is not obliged to disclose information that is held with a view to its publication at some future date.

The information you requested is intended to be published by Partnership for Action Against Wildlife

Crime Group, in the next few months and will be made available on / in the PSNI website.

Section 22 is a qualified exemption so therefore the PSNI is obliged to carry out a Public Interest Test.

Public Interest Test – Section 22

Factors favouring release

The public would be better informed of PSNI investigation of crimes against birds of prey and more specifically Red Kites.

Factors favouring withholding

Information in relation to crimes against birds of prey and more specifically Red Kites has a multiagency interest involving numerous organisations and not solely the PSNI. Detailed assessment of crimes against birds of prey is ongoing and reports when produced are issued on a multi-agency basis (as per the example provided in assistance to you under). Consequently the public interest is best served by awaiting the next detailed multi agency report in relation to crimes specifically against Red Kites, as well as other birds of prey.

To assist we have provided a link under to the 10 year report 2009 to 2018, which will provide information since 2017.

What steps have been taken to investigate wildlife crimes against Red Kites in Northern Ireland?

Answer
