Subject: Belfast 20mph Limit

Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

I was wondering if the Belfast centre 20mph speed limit is an actual legal limit? If so is there a time frame when this is operational?

Answer

The 20mph speed limits within Belfast City Centre are mandatory legal limits as indicated by the Regulatory signs when entering the limit and the repeater signs. The speed limit is enforceable 24hrs a day. A map and a list of the streets which are covered by the 20mph limit can be viewed on the Department for Infrastructure website.

Request 2

Is there an element of common sense involved here as well. For example if it is not busy and or safe to do so is it legal to drive at 25/30 mph?

Answer

20mph is the permissible upper limit, however this should not be seen as a target speed at which to drive in all circumstances but only when it is safe to do so.

In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
