**Subject:** Closure Of Police Stations

### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

#### Request 1

How many force police stations in operation at the start of 2010 are no longer operational? Please provide the name and address for each.

#### Request 2

How many force police stations closed since the start of 2010 had a public front counter where the public could speak to an enquiry officer? Please provide the name and address for each.

#### Request 3

How many force police stations are currently planned for closure? Please provide the name and address for each, and the expected date of closure (as accurately as is possible).

#### Request 4

How many of those stations currently planned for closure have a public front counter? Please provide the name and address for each.

The PSNI do not have any stations currently planned for closure. 'Planned' meaning that Districts/Departments have formally determined which Stations will close and PSNI has obtained Northern Ireland Policing Board approval to close.

You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
