Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Clarification to Requester

What are you referring to by 'sexual misconduct cases' (Question 4, 5 and 8)? Is this limited to misconduct hearings, or does it include sexual matters which have been investigated by Professional Standards; or reported to Professional Standards, which have not gone to hearing?

Clarification from Requester

This is limited to misconduct hearings.

Request 1

How many misconduct hearings were held by your police force in the financial years:

a. 2018- 2019 b. 2019-2020 c. 2020-2021 d. 2021-2022 (to date)

Answer

PSNI held the following number of misconduct hearings:

a. 2018- 2019 - 14 b. 2019-2020 - 7 c. 2020-2021 - 10 d. 2021-2022 - 10

Request 2

How many of the misconduct hearings above for the financial years between 2018-2022 (to date) were held in private?

Answer

All PSNI misconduct hearings are conducted in private.

Request 3

How many sexual misconduct cases were there in your police force in the financial years:

a. 2018-2019 b. 2019-2020 c. 2020- 2021 d. 2021- 2022 to date

Answer

PSNI held the following number of hearings related to sexual misconduct:

a. 2018-2019 - 3 b. 2019-2020 - 0 c. 2020- 2021 - 1 d. 2021- 2022 - 3

Request 4

How many officers were granted anonymity or were unnamed for sexual misconduct cases, can you break this down into male/female and other officers in the financial years from 2018-2022 (to date)?

Answer

As all PSNI misconduct hearings are conducted in private no officers were publicly named in relation to sexual misconduct cases.

Request 5

How many officers were given a final written warning were given anonymity or were unnamed for sexual misconduct cases, can you break this down into male/female and other officers in the financial years from 2018-2022 (to date)?

Answer

a. 2018-2019 – 2 officers received a final written warning b. 2019-2020 - 0 c. 2020- 2021 - 0 d. 2021- 2022 - 0

Both officers were male.

How many non-sexual misconducts hearings were held by your police force in the financial years:

a. 2018-2019 b. 2019-2020 c. 2020- 2021 d. 2021-2022 to date

Answer

PSNI held the following number of non-sexual misconduct hearings:

a. 2018-2019 - 11 b. 2019-2020 - 7 c. 2020- 2021 - 9 d. 2021-2022 - 7

Request 7

How many officers dismissed for gross misconduct were granted anonymity or were unnamed in non-sexual misconduct cases in the financial years between 2018 -2022 (to date). Can you break this down into gender male/female and other officers?

Answer

As all PSNI misconduct hearings are conducted in private no officers were publicly named in relation to non-sexual misconduct cases.

Request 8

How many officers given a final written warning were granted anonymity or unnamed in non- sexual misconduct cases , can you break this down into gender male/female and other in the financial years 2018- 2022 (to date)?

Answer

As all PSNI misconduct hearings are conducted in private no officers in receipt of a final written warning were publicly named.

Request 9

How many officers dismissed for gross misconduct were named, can you break this down into gender of male/ female and other officers for the financial years?

Answer

As all PSNI misconduct hearings are conducted in private no officers dismissed for gross misconduct were publicly named.

Request 10

How many officers given a final written warning were named, can you break this down into male/female and other officers for financial years 2018-2022 (to date)?

Answer

As all PSNI misconduct hearings are conducted in private no officers in receipt of a final written warning were publicly named.
