Subject: Royal Ulster Constabulary Height Restrictions

Request and Answer:

Your request for information has now been considered. In respect of Section 1(1) (a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

What were the height restrictions within the Royal Ulster Constabulary?

Answer

According to the last RUC Code held by the Police Museum dated May 1986, the minimum height requirements were as follows (under Regulation 10 The Royal Ulster Constabulary (Amendment) Regulations 1984:

Men 172 cm Women 162 cm

Please note the RUC Code states 'unless the Chief Constable with the approval of the Police Authority decides otherwise'.

The RUC Code contains a nota bene which states 'The Chief Constable using his discretion has increased the minimum height standard for female candidates to 168 cm'.

The Police Museum also holds an RUC recruitment pack dated 1994 in which the minimum height standard is given as men 172 cm and women 162 cm as recorded above.

Request 2

When were the height restrictions abolished?

Answer

Height restrictions were abolished under the Police (NI) Act 2000 and the Police Museum holds a copy of the Police (Recruitment) (Northern Ireland) Regulations 2001 (operational from 5th April 2001) in which there is no reference to height requirements for entry.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
