Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

## Request

Please can you provide me with the number of recorded offences under 'Domestic Burglary', Aggravated Burglary' and 'Commercial Burglary' in the financial years from 2017/19 to 2021/22.

If it is easily accessible, can you share the recorded outcomes and if charges were brought? Can you please break down the data on a spreadsheet by year and type of recorded burglary.

## Answer

The table provided below is based on all recorded burglary offences, broken down by the currently assigned outcome, for the period 2017/18 - 2021/22.

The figures provide the currently assigned outcomes for recorded burglary offences and please note outcomes may be updated as investigations are completed and / or new evidence is presented.

The three burglary classifications below consist of the following offences:

- Burglary Residential: 28E Burglary Residential, 28F Attempted burglary Residential, 28G Distraction burglary Residential, 28H Attempted distraction burglary Residential
- Aggravated burglary: 29A Aggravated burglary Residential, 31A Aggravated burglary Business & Community
- Burglary Business & Community: 30C Burglary Business & Community, 30D Attempted burglary -Business & Community

In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
