### Request and Answer:

## **Request Number 1**

Could you provide me with the percentage breakdown on the number of successful SPED (Purchase of evacuated dwellings) in Northern Ireland in the last 10 years which were signed off by the Chief Constable

## Answer

Please see the table below that provides the figures and percentages of the total amount of applicants who applied for SPED in the last 10 years and a breakdown of how many of those applications were successful.

The below data is the number of SPED applications from 1<sup>st</sup> January 2011 until 20<sup>th</sup> July 2021

Please note that the answer provided below is based on the information held by PSNI Security Branch in relation to SPED applications. PSNI Security Branch does not hold any other information about intimidation to answer this question more fully.

We have defined the term **Security Forces** quite broadly, and it relates to the following – PSNI Officers, PSNI Staff & Relatives, Former PSNI or RUC Staff, DOJ Staff, current HMF Personnel and ex HMF Personnel and current Prison Officers and ex Prison Officers.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
