## Request 2

What are the Terms of Reference of the Research, Engagement and Strategic Support team?

### **Answer**

- LIB was established in January 2015 following the cessation of the Historical Enquiries Team (HET) in December 2014.
- It has responsibility for terrorist & non-terrorist homicides that occurred between 01 January 1969 and 01 March 2004.
- LIB remit is to review those cases within this time period that were not concluded by the HET and to conduct investigations into cases which present evidential opportunities.
- The REDS team are responsible for the research & development of enquiries that sit outside the parameters of either LIB review or investigation teams.
- This includes cases that are not part of LIB's current caseload.
- To attempt to answer straightforward and specific questions posed, they will carry out cursory research & development of material that is readily available.
- They do not conduct a full review of an investigation or reinvestigate HET completed cases.
- They are bound by statutory obligations regarding material & information held in respect of any investigation.
- Such material & information cannot be disclosed to the public, except as required by an ongoing legal process or Production Order.

## Request 3

How many personnel are within the Research, Engagement and Strategic Support team?

#### **Answer**

There are 7 personnel within the Research, Engagement and Strategic Support team.

How many of these personnel have been deployed from PSNI/RUC, other UK police forces, the MOD or other agencies?

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
