Request and Answer:

You have sought the following information from PSNI under the Freedom of Information Act 2000 ('FOIA'):

"I request details of all notes, minutes, records, emails, decision logs, actions and any record how so ever held in respect of the decision not to play the National Anthem of the United Kingdom of Great Britain and Northern Ireland at events for the presentation of the Police Long Service and Good Conduct Medal"

Answer

Whilst we apologise for the delay in responding to you, PSNI can confirm it has made extensive searches for the information you seek. Whilst we hold information on the relocation and presentation of the Police Long Service and Good Conduct Medal ceremonies commencing in the Spring of 2019 to locations outside of the PSNI estate, we do not hold any information in regard to an organisational decision not to play the National Anthem of the United Kingdom of Great Britain and Northern Ireland at these ceremonies. The ceremonies were relocated to civic venues and reformatted, running at times aimed at encouraging and faciliting wider participation, taking into account the needs of those families of recipients attending, including young people and school children.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request; you may make a complaint to the Information

Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act.
