## Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

## Request 1

How many times the Road Safety speed cameras from the designated units and local roads policing have been deployed in the 40 and 30mph zone between the roundabout at Killinchy Street, Comber where the A21 meets the A22 and the end of that zone towards Killinchy both in and out of Comber?

## Answer to Requests 1 2 and 3

Between 1<sup>st</sup> August 2018 – 31<sup>st</sup> July 2021 the Northern Ireland Road Safety Partnership (NIRSP) van has deployed to Killinchy Road, Comber (30mph limit) 52 times, resulting in 360 detections.

The maximum speed detected was 55mph.

The NIRSP van has not enforced on Killinchy Road, Comber within the 40mph limits within this time period.

The number of deployments made by police officers is not recorded on any police system and therefore cannot be provided.

The number of speeding detections made by police officers within 30mph limits on Killinchy Road,

Comber over the same time period is 12, where the maximum speed detected is 63mph.

There are no detections recorded for the 40mph limit on Killinchy Road, Comber.
