Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request

Under the Freedom of Information Act, I would like to request information about the following airports:

- Belfast International Airport
- George Best Belfast City Airport

For each of these airports, I would like to request the following:

- 1. Number of arrests
- 2. Most common offences

For both of these, I would like the data broken down for 2019, 2020 and 2021, if possible.

Answer

Please see below information in relation to your request, which has been extracted from the custody arrests data. Please note the figures are based on persons arrested and processed through police custody in each of the calendar years: 2019, 2020 and 2021.

The custody records provided in the two tables below have been classified based on the most serious offence the person was arrested for.
