Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request

I am looking for road collision figures for the Castledawson roundabout in Magherafelt since the exit for the Cookstown bypass was added in October 2016. I know there have been a lot of collisions that have occurred on this particular roundabout since the extra exit was added for the Cookstown bypass as people aren't clear about what lane they need to be in for certain exits. There was also a death of a six year old boy who died as a result of a crash on the roundabout last week. The figures don't need to be of fatalities, just any collisions that have occurred.

Answer

Please see below collision history of Injury Road Traffic Collisions that took place at the Castledawson Roundabout, Magherafelt and been reported to the Police Service of Northern Ireland from 1st of October 2016 to 31st of December 2021.

Figures below relates only to collisions where an injury was involved and reported to Police. PSNI do not collect data on damage only collisions.

Please be aware that these include collisions at or within 50 metres of the mentioned roundabout

Road Traffic Collision location data for 1st of January 2022 - 1st of June 2022 is not available in a complete or retrievable format until we receive and validate all of the Collision Report Forms and upload them onto the PSNI mapping system, which occurs just after publication of the data. This result in a delay between when an injury involved RTC occurs and when it becomes available to be released to the Public. Data for 1st January 2022 - 31st of March 2022 will become available on the 29th July 2022.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review.
