#### Request and Answer:

Please could you let me know if you are able to provide the figures for the number of calls your force received from alleged victims of domestic violence or abuse from 11am last night until 11am today? (dated 14<sup>th</sup> July 2021)

There were 30 reports made during this period.

If possible, please could you let me know how this figure compares to a usual 24 hour period?

### **Answer**

We have taken the two days before and two days after for comparison.
