Subject: Police Cells Used As A Place Of Safety

Request and Answer:

Request

Please could you tell me how many times police cells were used as a 'place of safety' for adult patients sections under the mental health act for each month between (and including) January 2017 and June 2021?

For each month, please could you tell me both the average amount of time and the maximum amount of time that individual patients were kept in police cells?

Answer

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does not hold information in relation to your requests. Enquiries made in relation to your request failed to locate any records or documents relevant to your request based on the information you have provided.

PSNI does not hold any specific data that accurately reflects when a PSNI cell within a custody suite has been used purely as a "place of safety", if and when someone has been detained under the Mental Health (NI) Order 1986. PSNI have made it known that there may be circumstances when an individual is detained for alleged criminal activity and detained in a PSNI cell. They may in turn have mental health issues but this would not be the reason specifically for their detention. In essence the occupation of a cell would not then be deemed to be utilised as a "place of safety". Generally when this terminology is used it refers to a "PoS" awaiting psychiatric bed allocation. It is the policy of the PSNI not to detain individuals in these circumstances in cells but to convey the individual directly to hospital to best cater for their needs and treatment.

Accordingly, I have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
