Subject: Sgt. Promotions Projections

Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold some information to which your request relates and this is being provided to you. We do not however hold information in relation to request number 3 below.

Request 1

This is a follow up to F-2022-01103. In the aforementioned FOI, PSNI responded that only 47 Sgt promotions are projected up to 2024.

Are these posts to be filled from the 116 persons already on the merit list established in 2021 or are those people on projections from 2019/2020/2021 that were not asked for/included and therefore the 47 vacancies are seen as entirely separate to the merit list established in 2021?

Answer

Information provided as a response to F-2022-01103 was incorrect. New figures and an apology were provided and communicated to you on 19th of July 2022.

The forecasted promotions required for Sergeants to 31 March 2024 (as at 24 June 2022) was 167. The current merit list had 114 officers remaining on it (as at 24 June 2022) and this results in a shortfall of 53. It is anticipated this shortfall would be filled from a new Sergeant promotion process due to launch in 2023.

Request 2

Please provide the Sgt promotion projections from 2019/2020/2021.

Answer

Projections of future promotions are changing regularly based on the budgets available and the number of leavers from Service therefore posts were filled accordingly. However please see below number of officers, who have been promoted to the rank of Sergeant in 2019, 2020 and 2021:

2019 – 65 officers 2020 – 210 officers 2021 – 2 officers

Request 3

Please provide any new relevant minutes of meetings that discuss workforce projections going forward, promotions and timelines for officers to be appointed up to and including the rank of Superintendent.

Answer

Enquiries made with the appropriate department in relation to this part of your request failed to locate any records or documents relevant to your request based on the information you have provided. Accordingly, we have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.
