Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Answer

Offence codes containing the text 'abort' were identified and the legislation checked to confirm they are contained within the OAP Act 1861 S58/59. An additional offence code (4106006) relating to S60 of the legislation was included in the search but no records were identified for the time period requested. A cross check with the offence charge text (where this mentioned the relevant act in legislation).

The following offence codes were retrieved for the time period January 2012 to date: 4106002 (procuring for another an abortion by administering a poison) and 4106008 (procuring own abortion using an instrument)

From the period January 2012 to today's date, three males have been arrested for abortion related

offences. There were no convictions as a result of these arrests. Two females were convicted for abortion related offences in 2014.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
