Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold some information to which your request relates and this is being provided to you. We do not however hold information in relation to what Inspector Vacancy Bulletins were advertised between 2015 & 2018.

Request

We would be grateful if you could provide us with details relating to Inspector positions available between 2015-2018, to include rates of pay.

Answer

We are unable to confirm what Inspector Vacancy Bulletins were advertised and details of same during this period as records have been destroyed in line with the Review, Retention and Disposal Schedule.

We can confirm that there was an Inspector promotion process advertised on the 5th September 2016 which was subsequently re-advertised on 20th February 2017.
