## **Request and Answer:**

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold the information to which your request relates and this is being provided to you. The decision has been taken to disclose the following.

## Request

We are reviewing our village wide anti-drug campaign and its effectiveness so to help facilitate it may I request the following information please for the village of Dervock Co Antrim.

May I have statistics regarding number of drug related crimes or offences committed within the village for the following time frame.

May I have it Broke down by year For: 1st July 2018- June 30th 2019 1st July 2019- June 30th 2020 1st July 2020- June 30th 2021 1st July 2021-June 30th 2022

## Answer

Based on the time periods in your request, the number of drug offences (trafficking and possession offences) recorded by the police for the Dervock administrative ward (2014) are:

1<sup>st</sup> July 2018 to 30<sup>th</sup> June 2019 - 3 1<sup>st</sup> July 2019 to 30<sup>th</sup> June 2020 - 3 1<sup>st</sup> July 2020 to 30<sup>th</sup> June 2021 - 7 1<sup>st</sup> July 2021 to 30<sup>th</sup> June 2022 - 5

Please note that the figure for July 2021 to June 2022 is provisional and potentially subject to change.

It is also worth noting that the figures you have requested are already available in the public domain and are easily accessible at any time. Drug offences (trafficking and possession offences) recorded by the police for the Dervock administrative ward (2014) or any other administrative ward in Northern Ireland are available for each financial year in the police recorded crime data (administrative geographies) section of the NINIS website, found at the link below:

The figures on this website are regularly updated and will continue to be a publically accessible source of information to anyone seeking figures of recorded crimes in various administrative areas.

<u>Please note:</u> from our enquiries we also noted that you had a previous FOI request with PSNI last year (FOI-2021-00920) where you asked for the same information and this was ultimately provided to you. You may notice that the figures for this request differ slightly from those supplied in your previous request.

We wanted to make you aware that the reason for this is because your previous request (FOI-2021-00920) asked for the figures for the financial years which is April to March and for this request (FOI-2022-01880) you asked for the figures for July to June of each year. This change of timeline would explain why there are slight differences in the data for some of the same years in both requests.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review.
