Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Please provide statistics for all road traffic collisions between 2012 and 2022, their types, recorded causes and injuries, which have occurred at the Whiney Hill / Ballymiscaw Road junction of the B170 at Craigantlet, County Down, coordinates: 54°37'16.8"N 5°46'37.6"W

Answer

Please see attached Excel Spreadsheet titled 'Collision history Whiney Hill-Ballymiscaw junction Spreadsheet' in response to your request. Tab 1 provides a summary, tab 2 provides greater detail.

The figures outlined in this Spreadsheet relate to collisions where an injury was involved and reported to police and not damage only collisions, as this information is not held centrally. The latest available data for 2022 is to 31st March.

You
