Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

The total number of positions at all ranks within the Public Protection Branch – breakdown per district

Clarification sought: By ranks is this just Police Officers and not staff? Public Protection Branch is not part of districts they are broken down by trusts such as North, Belfast etc.? There are other units within Public Protection which do not sit under these Trusts, are you the requestor content these are shown as separate? – This will also refer to a number of other questions 3, 4, 5,

Clarification received: This is acceptable.

Request 2

The number of these posts that have not been filled / persons not appointed – breakdown per district

Clarification sought: Is this with Temporary Promotions and Temporary Transfers reverted?

Clarification received: The request is based on what roles are currently vacant and do not have a member of staff completing.

Request 3

The number of current staff on sick leave @ week ending 05/09/2021 – breakdown per district

Clarification sought: Reports we run are based on a monthly basis, so it would be for 31/08/2021

Clarification received: This is acceptable.

Request 4

The number of days lost in 2019/2020 & 2020/2021 tax years due to sickness – breakdown per district

Clarification sought: For the whole of PSNI or just Public Protection?

Clarification received: All information for Public Protection Branch.

Request 5

Nature of sick leave – i.e. percentage breakdown for areas – Musculoskeletal, Mental Health (Stress, Depression etc.), Injury on Duty, Maternity Leave etc - breakdown per district

In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
