

# FREEDOM OF INFORMATION REQUEST

**Keyword:** Human Resources

Subject: Assaults against Police Officers

#### Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1) (a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner's Office guidance 'Requests where the cost of compliance exceeds the appropriate limit' in relation to this request, which also provides further detail on the application of section 12 (1) of the FOIA. You requested the following information from PSNI:

# Request 1

How many police officers have been assaulted at work each year in the years 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020?

## Request 2

How many police officers have required medical attention due to assaults against them during the years 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020?

### Request 3

How many police officers have required time off work for mental or physical health recovery resulting from assaults against them during the years 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020?

I would also like for the data for each year to be separated rather than collated. So, the number of police officers assaulted at work in 2005 and then the number of police officers assaulted in 2006

and then the number of police officers assaulted in 2007 etc. Rather than the total number from 2005-2020. Please can I have the data in calendar years.

#### **Answer**

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The 'appropriate limit' is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

When a public authority is estimating whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if the conditions laid out in Regulation 5 of the Fees Regulations can be satisfied. Those conditions require the requests to be:

- made by one person, or by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign;
- made for the same or similar information; and
- received by the public authority within any period of 60 consecutive working days.

Regulation 5(2) of the Fees Regulations requires that the requests which are to be aggregated relate *"to any extent"* to the same or similar information. This is quite a wide test but public authorities should still ensure that the requests meet this requirement.

Enquiries made in relation to your request has identified that retrieval of information would exceed the FOI legislative cost of 18 hours as set by the Secretary of State. In relation to request three, 7870 assaults have been recorded during the listed time period. The relevant business area has estimated that it would take 15 minutes to assess each individual record electronically or review a paper copy if the incident occurred prior to 2012. For all incidents that occurred prior to 2012; a hard copy of the documentation would need to be requested from file management. Each electronic or paper record would need to reviewed to consider the details of the incident, and to determine whether or not time off work was required for mental or physical health recovery resulting from assaults. It is estimated it would take 1,967 hours to complete this assessment for all relevant records. Furthermore the above

actions could not guarantee that we would be able to determine whether or not time off work was required for mental or physical health recovery following assaults. The effect of an assault (physical or mental) may not be evident at the time of the incident but could occur many months or years after the initial incident, and the individual may not be aware that their absence is a result of an incident which occurred many years before. To retrieve the information for request three alone, grossly exceeds the legislative timescale of 18 hours.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

## **Advice and Assistance**

Under Section 16 of the FOIA, PSNI will always try to assist you to refine your request and provide advice where we can. PSNI has considered how your request may be refined to bring it under the appropriate limit and we are unable to offer you refinement due to how information is stored by relevant business areas.

However we can provide the following information in respect of Request 1. Figures for assault with injury on a constable and assault without injury on a constable for each financial year 1998/99 to 2020/21 are published on the PSNI website. These figures represent assaults where the police officer was on duty at the time of the assault. The latest data series is published in the financial year update, period ending 31 March 2021 spreadsheet table 11 (violence against the person classifications 8S and 104).

In respect of Request 2, the relevant business area has advised that they can provide applicable data from July 2012 to December 2020.

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
